2. The AAB members were introduced by the HoDs of various departments.
3. The Principal presented the activities of the college for last one year and he opened the forum for discussion and deliberations. The board members appreciated the efforts of the stake holders for their contributions to the institute.
4. The Board members participated actively and gave the following suggestions:
 - a. The pandemic situation has changed the education system and it is very essential for the Institution to train and motivate the faculty to engage the online class so as to facilitate the students to be placed in good companies.
 - b. The BoS at the Institute level should actively take part in the syllabus review so that the University syllabus (2021 scheme) is in alignment with NEP 2020.
 - c. The Institute should provide more emphasis on Research and Innovation so that a greater number of faculty and students publish papers in peer reviewed journals.
 - d. The faculty should be motivated to write proposals in alignment with various funding agencies to improve the grants at the Institute level.
 - e. Young and successful entrepreneurs should be invited to motivate the students to involve in ABiC activities and become budding entrepreneurs.
 - f. All the above points would lead to improved ranking in NIRF (National Institutional ranking Framework) and ARIIA (ATAL Ranking of Institutions on Innovation Achievements).
5. The Principal said that we have various policies like providing OOD/registration fees to attend FDP/training, cash award for paper publication in Scopus and above, sharing of revenue earned under consultancy etc. to motivate the faculty for personal growth and ultimately improve the ranking of the Institution.
6. The heads of the department also shared their opinion on the suggestions given by the AAB members.
7. The meeting concluded with the principal thanking the members present.
